

Appointment: Is a formal work authorization made by an insurance company to the State. It authorizes the licensee to write business for that insurance company.

Immediate States (Non JIT): An insurance company must file the appointment when agent's contract is executed or when the first piece of business is received, whichever occurs first. Non-resident appointment fees and any applicable servicing fees will be deducted directly from your commission, or from your upline if you are not paid directly by Amerigo, at the time of contracting if the below states are listed on the Contract.
